I am pleased to transmit to you the following comments for your draft Elmira Township Master Plan as excerpted from the draft minutes of the October 5, 2004, Antrim County Planning Commission minutes:

8. Elmira Township Master Plan Review

The Chair noted that comments were due to Elmira Township this week, and went around the table soliciting comments from the ACPC members.

Member comments included:

- Kudos from the majority of ACPC members on a job well done, on good readability
 of the text:
- Kudos for recognizing that neighboring townships in Antrim County are unzoned, and recognizing the need for taking that fact into account;
- Consider inclusion of a summary section at the end of the data-heavy chapters (demographics and econ data, especially), giving a paragraph or two of narrative interpreting the overall picture of the Township as gleaned from the numerous tables of numbers;
- General agreement that Appendix B, as presented, could be construed as discriminatory and offensive to many people. The "Weeds to Get Rid of..." section, with its inclusion of snowmobiles and trailer housing, drew the most negative comments from ACPC members:
- Staff reminded ACPC that Appendix B is the data backup from the visioning sessions for public input that the Township has held for the master plan process;

Motion by Tom Maleck, seconded by Joe Allen, to recommend to the Elmira Township Board to accept the proposed Elmira Township Master Plan, provided that Appendix B be removed.

Public Hearing

A public hearing on the proposed Master Plan for Elmira Township as required by the Township Planning Act, Act 168 of 1959 as amended, was held November 3, 2004. Section Nine of the Act requires that two notices of public hearing be given, the first to be published 20-30 days prior to the public hearing, and the second to be published not more than eight days prior to the public hearing. Notice of the public hearing was published in the Gaylord Harold Times on October 13, 2004 and October 30, 2004. A copy of the public hearing notice is provided below:

Elmira Township Master Plan Public Hearing

Elmira Township Planning Commission will hold a public hearing on the proposed Elmira Master Plan at 7 pm on Wednesday, November 3, 2004, at the Elmira Township Hall located at 2035 Mt. Jack Road, Elmira. Interested parties are invited to review a copy of the plan on the Planning Commission portion of township website at http://www.otsego.org/elmira, at the Otsego Public Library in Gaylord, or by contacting Duane Hoffman, PC Chair at (231-546-3324). Comments can be sent to the Elmira Township Planning Commission Chair, 1233 W. Martin Lake Rd., Gaylord, MI 49735 or comments may be made at the public hearing.

Additional notice of the public hearing was mailed to all Elmira Township property owners notifying them of the November 3, 2004 Public Hearing. A copy of the public hearing information was placed at the Elmira Township Post Office, Elmira Grocery and at Hops & Schnapps.

The purpose of the public hearing was to present the proposed Master Plan and to accept comments from the public.

The public hearing began with a brief explanation of the planning process. Plan development included several Planning Commission workshop meetings, and input from the Township Board. During the hearing, maps of existing land use, natural resources, and proposed future land use recommendations were presented. Following are the minutes from the Planning Commission public hearing.

Elmira Township Planning Commission Public Hearing Notes for Draft Master Plan Draft Master Plan Dated June 2004

Duane Hoffman, Elmira Township Planning Commission chair called the public hearing to order at 7:00 p.m. From the Elmira Township Planning Commission (ETPC) were Hoffman, Gloria Torello, Jim Theisen, Diane Purgiel, Jack Middleton, John Ernst-who serves in an advisory role; and Mary Campbell-who served as the consultant. In the audience there were approximately 32 people. Members from the Elmira Township Board were present also.

Hoffman explained the purpose of the public hearing, and how the hearing would proceed, and the intent of a master plan. Mary Campbell presented the draft master plan through narrative during a power point presentation. Various questions were answered through out the evening.

Questions included:

- Can the open areas in Glen Meadows be built on;
- Why are junk cars and blight not being cleaned up;
- What can be done with the Zaremba property;
- What does the plan do to draw business into Elmira;
- What can go into the Business and Light Manufacturing areas;
- Why are there not more Business and Light Manufacturing areas along M-32;
- How much did it cost to develop the master plan;
- How much would it cost to have Township zoning;
- What is being done about wind turbines?

Campbell explained the process to adopt the master plan. There was a lot of interest and discussion during the public hearing. The hearing was tape recorded. The hall was set up so people could sit at a table. There were coffee and cookies offered. The hearing closed at about 9:00 p.m.

Plan Adoption

The Planning Commission formally adopted the Master Plan at a regularly scheduled Planning Commission meeting on November 22, 2004. The Township Board adopted the Master Plan at a regularly scheduled board meeting on January 13, 2005. The minutes from both the Planning Commission meeting and the Township board meeting are provided at the end of this chapter.

Legal Transmittals

Michigan planning law requires that the adopted Master Plan be transmitted to the adjacent townships and counties. A copy of the transmittal letter and list of adjacent townships and counties to which the plan was sent are provided at the end of this chapter.

Plan Implementation

A Master Plan is developed to provide a vision of the community's future. It is designed to serve as a tool for decision making on future development proposals. A Master Plan will also act as a guide for future public investment and service decisions, such as the local budget, grant applications, road standards development, community group activities, tax incentive decisions, and administration of utilities and services.

According to the Township Zoning Act, master planning is the legal basis for the development of a zoning ordinance. Section Three of the Act states: "The zoning ordinance shall be based on a plan designed to promote the public health, safety and general welfare; to encourage the use of lands in accordance with their character and adaptability, and to limit the improper use of land; to conserve natural resources and energy; to meet the needs of the state's residents for food, fiber, and other natural resources, places to reside, recreation, industry, trade, service, and other uses of land; to insure that use of the land shall be situated in appropriate locations and relationships; to avoid the overcrowding of population; to provide adequate light and air; to lessen congestion of the public roads and streets; to reduce hazards to life and property; to facilitate adequate provision for a system of transportation, sewage disposal, safe and adequate water supply, education, recreation, and other public requirements; and to conserve the expenditure of funds for public improvements and services to conform with the most advantageous use of land resources, and properties."

Zoning

The Zoning Ordinance is the most important tool for implementing the Master Plan. Zoning is the authority to regulate private use of land by creating land use zones and applying development standards in various zoning districts. Elmira Township is under the Otsego County Zoning Ordinance. The Ordinance has provided guidance in regulating the location, density and standards for local development. The Zoning Ordinance, as it pertains to Elmira Township, should now be reviewed to ensure consistency between the Ordinance and this Master Plan. If areas of difference are identified then Elmira Township may wish to request the County consider some specific changes to the Zoning Ordinance.

Grants and Capital Improvement Plan

A Master Plan can also be used as a guide for future public investment and service decisions, such as the local budget, grant applications and administration of utilities and services. Many communities find it beneficial to prioritize and budget for capital improvement projects, such as infrastructure improvements, park improvements, etc. A Capital Improvements Program (CIP) is one tool which is often used to establish a prioritized schedule for all anticipated capital improvement projects in the community. A CIP includes cost estimates and sources for financing for each project, therefore can serves as both a budgetary and policy document to aid in the implementation of a community's goals defined in the Master Plan.

Hoffman reported a Hamlets meeting will be held November 23, 2004. He plans to attend and provide information at the next PC meeting.

Theisen reported Bagley Township does not want to accept the County's visioning plan. No report this month on the Forest and Agriculture Task Force.

Theisen reported Livingston Township Planning Commission has a new supervisor. The master plan revision are wrapping up. See their web site at: www.otsego.org/livingson

Middleton was not present to give a report on Corwith Township. Corwith Township Planning Commission has no web site.

F. New Urban News: Torello reported on the given article. The News will be routed to PC members each month.

G. Draft Master Plan:

On Wednesday November 3, 2004 the public hearing was held for the draft master plan Duane Hoffman called the public hearing to order at 7:00 p.m. From the Elmira Township Planning Commission were Hoffman, Gloria Torello, Jim Theisen, Diane Purgiel, Jack Middleton, John Ernst-who serves in an advisory role; and Mary Campbell-who served as the consultant. In the audience there were approximately 32 people. Hoffman explained the purpose of the public hearing, and how the hearing would proceed, and the intent of a master plan. Mary Campbell presented the draft master plan through narrative during a power point presentation. Various questions were answered through out the evening. Campbell explained the process to adopt the master plan. There was a lot of interest and discussion during the public hearing. The hearing was tape recorded. The hall was set up so people could sit at a table. There were coffee and cookies offered. The hearing closed at about 9:00 p.m.

From Mary Campbell, the PC members would like to see the changes and corrections to the draft through 11/22/04 before the final approval of the draft master plan is given by the PC. The PC members would like to proof a "pre-final draft" before it is distributed. By copy of these notes, **Campbell** will be notified of this. With that exception, Purgiel moved and Hoffman seconded a motion to adopt the draft master plan as revised through November 22, 2004. The motion passed unanimously. **Purgiel** will bring the information to the Elmira Township Board.

Going forward with the master plan, the PC needs to work on the following:

- 1. Mixed use, what does this include? **Hoffman** will make a first draft of this.
- Zoning to match master plan. Torello will make a first draft of this. Areas include the NE corner of Camp Ten Road and M32, Mixed use areas, Expansion of B2 areas, the "Pink" area on the draft plan, State of Michigan land areas.
- 3. Forest/Ag-a "tool box" of ideas may be developed as ways to retain forest/ag lands.
- 4. DDA, what is needed to go forward with this?
- 5. Recreation plan.
- 6. Other.

H. By-Laws:

This was tabled until the next PC meeting. **Purgiel** will follow up with the Township attorney on the issue of Article V, 4. who is "responsible for ordinance(s)." Is this the Planning Commission as has it has been interpreted in the past? Or is it the person the Township Board retains to enforce compliance of the nuisance ordinance? Depending on the decision, Article II. 2. may need to be update as well.

I. Billboard Ordinance:

Discussion included changing the maximum size of a billboard in the ordinance. After reviewing past cases provided by the Township attorney, the PC members want the billboard size in the ordinance to remain the same. The existing size in the ordinance meets with the goals of the draft master plan. The existing size helps retain the rural character of Elmira Township. The existing size helps prevent light pollution; maintain property values; protect open space; and serves as a safety feature.

J. Budget: Purgiel presented a proposed budget for 2005 of \$13,135.00. Purgiel will bring this before the board. See attachments for details.

K. Other: Torello continues preparing a disk containing electronic copies of the original billboard ordinance, the amendment, and the application; and the notice of violation letter; and other PC documents. The disk will be held on file at the Township.

Purgiel will ask Theresa Plachta to put on the Elmira Township website the PC's meeting dates.

L. Next Meeting: Unless there is an application to review, the next PC meeting will be January 25 2005. Hoffman will contact PC members as necessary.

Finishing up a few more building permits. All deeds and homestead forms are current and maintained as they come in. 2005 Work roll is almost ready to add new buildings in and land values are being established and reviewed from the Equalization Department sales study.

Eighty Six Personal Property Statements and twelve buildings/towers on leased land were sent out on January 12, 2005. They have started to come in.

Jill is seeking the value Equalization charges to print Personal Property Statements and Assessment Change Notices per parcel. She is checking on alternatives which may be cost effective.

There were no Land Divisions.

Section 9 to read: The township planning commission chairperson or other person designated by the township planning commission is hereby designated as the authorized official to issue municipal civil infraction citations directing alleged violators of this Ordinance to appear in court. Seconded by Leonard and carried unanimously.
